NOW THIS TRUST DEED WITNESSETH AS FOLLOWS :

1. In order to effectuate the said object of creating and establishing a Educational Trust, the author has delivered to and made over to the Trustees a sum of Rs. 10,000/- (Rupees Ten thousand only) with intent to part with all his right, title and interest claim therein and vest the same in the Trustees to have and to hold the same and the investment or the investments for the time being representing the same together with all additions and accretions thereto and all accumulated income thereof and all other property or properties that may be acquired out of the same or otherwise may hereafter be subject to the trust (hereinafter referred to as "The Trust Fund") for the charitable objects and purposes and uses hereinafter with the powers and on the terms and conditions herein contained of and concerning the same.

3. The Trustees may establish its office at such place or places and may change such places from time to time as they may think fit.


AIM AND OBJECTS OF THE TRUST :

- (v) To do all acts and things necessary to facilitate the charitable, social, cultural, educational, vocational and economical development of the society.
- (vi) To collaborate with institutions and individuals who share the same ideals and are desirous of organizing relevant programmes.
- (vii) To provide financial and other assistance to poor and economically vulnerable persons requiring medical aid and to institutions engaged in provided medicare.
- (viii) To support a wide range of programmes and activities that would improve environmental and ecological conditions in the country and to collaborate with institutions, agencies or bodies engaged in similar work.
- (ix) To purchase or to take on lease lands, buildings and other immovable or movable properties in the name of the Trust.

5. If any one or more of the objectives specified in Clause 4 of these presents are held not to be the objects of a public charitable nature, the Trustees shall not carry out such object or object(s) as if the same are not incorporated in these presents but the validity of the Trust created by these presents as a Trust for Educational purposes shall not be affected in any manner.

APPLICATION OF FUNDS

6. The Trustees shall from time to time after meeting the expenses of and incidental to the management of the Trust Properties and of the Trust decide the particular object(s) for which the income or expenses of the Trust Fund or properties for the time being available shall be applied.

FUNDS OF THE TRUST INVESTMENT

7. The Trust Funds not immediately required for the purposes of the trust shall be invested in such manner as stipulated under the provisions of Section 13(1)(d) read with Section 11(5) of the Income Tax Act, 1961 or as per provisions of Income Tax Act as amended from time to time.
8. In addition to the Corpus Fund the Trustees may accept any donation or contribution in cash or in kind from any person, firm, company, corporation, association, institution or Trust (including the author or the Trustees or any of them) for the furtherance of the objects of the Trust or for any one or more of them upon such terms and conditions as they may in their absolute discretion think fit and which are not inconsistent with the objects of the Trust. The Trustees may also take over the management of any other charitable or public institution on such terms as they think fit, however in line with the objectives of the trust and manage such institutions.
9. If the income from the Trust property in a particular year is not fully utilized, the unexpended income subject to the applicable provisions of the relevant laws in force, shall be carried over to the next year or years and spent in such subsequent year(s) for the advancement of any of the object of the Trust.

OPERATION OF BANK ACCOUNT

10. The Trustees shall keep account(s) with any Schedule Bank(s) to operate such account(s) whether in debit or in credit and to give all appropriate instructions to the banker(s) concerning the operation of such account(s) by Settlor or any other Trustee who is specifically authorized to operate such bank accounts by the Board of Trustees.

ADMINISTRATION AND MANAGEMENT OF THE TRUST

11. The affairs of the Trust will be managed by the Board of Trustees. The number of trustees shall be not less than three and not more than five at any time in future. Initially the Board of Trustees may be constituted by the Trustees of the other part.
12. All the Trustees except Life Trustees unless they voluntarily resign or otherwise decide, shall continue to be trustees during their term. The tenure of the trustees appointed by Trustees of the other part shall not exceed 3 years.
13. Any Trustee may retire at any time without assigning any reason and without being responsible for any costs occasioned by such retirement.
14. The power to appoint new or additional trustees, but so as not to exceed the maximum number and to fill vacancies in the office of the Trustees, shall vest with the Trustees of the other part.

15. No person being : (i) an undischarged insolvent or (ii) ¹⁰⁻¹¹ convicted of an offence involving moral turpitude, (iii) of unsound mind or (iv) minor shall be eligible ^{to be} a Trustee.

16. A person shall cease to be a Trustee in any of the following events :

- (i) If he dies;
- (ii) If he becomes insolvent;
- (iii) If he becomes insane or otherwise become incapable to act; or
- (iv) If he resigns his office.

17. On a new or additional Trustee being appointed and on his signifying his acceptance in writing to the effect of his accepting the appointment, the Trust property shall automatically vest in him along with the other Trustees for the time being and he will be entitled to carry out all the duties and functions of a Trustee without any other deed or writing.

18. The Board of Trustees may by a majority vote for the time being except the Trustee proposed to be removed, remove any Trustee, from office after finding the Trustee proposed to be removed guilty of serious misconduct in relation to or concerning the Trust estate or Trust affairs and after arriving at a definite conclusion that for the reasons to be recorded in writing the continuance of the trustee proposed to be removed as trustee of these presents was not desirable keeping to the objects of the trust in view and other related or connected matters provided however no

conclusion of such guilt shall be arrived at without giving to the Trustee proposed to be removed a full and fair opportunity of explaining his conduct and the changes leveled against him for his removal. And the decisions of the Board of Trustees in this behalf shall be final and binding and shall not be called in Question anywhere.

19. The Board of Trustees shall have all the powers to appoint persons to carry out the affairs of the Trust and to remove them if found necessary.
20. The Trustees may reimburse themselves and pay and discharge out of the Trust Fund all expenses incurred by them in or about the execution of the Trust or any of their duties under these presents including travelling expenses, but will not be entitled to any remuneration.

MEETING OF THE TRUST

21. The Trustees may meet as often as considered necessary for the transaction of the business of the Trust, but they shall meet at least once in a year to consider the income and expenditure of outgoing year.
22. Notice of the meeting of the Trustees and all communication may be sent to the Trustees at their addresses registered for the time being in the records of the Trust.
23. All meetings of the Trust shall be held at such place and at such time as the Trustees shall decide from time to time.


QUORUM

25. Majority of the Trustees at a meeting shall form a Quorum for any meeting of the Trust.
26. In case of difference of opinion between the Trustees the opinion of the majority shall prevail and if the Trustees are equally divided in any matter, the chairman shall have a casting vote.
27. A resolution in writing circulated amongst all the Trustees and signed by majority of trustees shall be as valid and effectual as if it had been passed at a meeting of the Trustees duly called and convened.

MINUTES OF THE MEETING

28. The minutes of the proceedings of every meeting of the Trustees shall be entered in a book to be kept for that purpose and signed by the chairman of such meeting or of the following when they are read over and shall when so entered and signed be conclusive evidence of the business and other matters transacted at such meeting.



29. The Trustee shall cause true and accurate accounts to be kept of all monies received and spent and of all matters in respect thereof in course of management of trust properties or in relation to the carrying out of the objects and purpose of the Trust as well as of all assets, credits and effects of the Trust properties.
30. The Trustees shall have them audited by a Chartered Accountant or any other person qualified to audit accounts of a joint stock company and Treasurer shall primarily be responsible for bookkeeping and preparation of annual statements.

FUNCTION OF TRUSTEES

31. Without affecting the generally of powers and functions of the Trustees to manage and administer Trust, Board of Trustees shall have following functions.
- (1) To appoint or make provision for the appointment of a sub-committee of and/or others to attend to or supervise or conduct specific jobs or functions or trust matters in such matter and subject to such rules and regulations as the Trustees may prescribe.
- (2) To authorize any one or more trustees to invest, hold, dispose or transfer any property or any fund or any investment of the Trust subject however to the terms of these presents in such manner and subject to such terms and conditions, rules and regulations as Board of Trustees may from time to time think fit and proper.

(3) To spend any portion of the corpus or the income of the trust fund for purchasing any land and/or constructing any building or buildings for and in executing any or all of the objects of the Trust.

(4) To acquire by lease, purchase, gift, mortgage, license as beneficiary under any other trust or otherwise all properties movable and immovable from Government or Semi Governmental authorities, Trust, Corporations, Institutions, Societies as well as individuals and to sell, alienate, gift, lease, mortgage, manage or in any other legal manner transfer all or any of the properties belonging to the trust and also to give the same on lease, hire, license or otherwise, for the furtherance of the objects of the trust.

(5) To raise secured and unsecured loans from any scheduled bank or any financial institutions or firm or individuals and/or any other institutions including Registered Society or Trust on such terms and conditions as the Trustee may decide from time to time for furthering the objects of the trust.

(6) To receive grants, gifts, endowments, and donations in cash or kind (as Corpus or otherwise) from individuals or associations or companies or Government etc., and to collect interest and other income of the trust for being utilized for furtherance of the aims and objectives of the trust.

(7) To do all such lawful acts that are incidental, ancillary or conducive for the attainment of any of the above objects and that are of benefit to the community.
